#### **GENERAL INFORMATION**

The Advantage Pellet and Applicator together are a convenient system for providing AquaGro® turf surfactant on a supplemental basis. Volume of water used ensures complete plant safety under any weather condition.

### **DIRECTIONS FOR USE**

The Advantage Applicator fits a 1-inch hose, or may be connected to a 3/4-inch hose using the adaptor. The Advantage Pellet will dissolve in about 1 hour at water pressures of 60 to 90 p.s.i. One pellet should permit you to cover about 6-7 average sized greens, watering at a rate of 10 mins per green. Insert one Advantage Pellet in the applicator jar. The rate at which a pellet dissolves varies with water pressure, quality, flow rate and temperature. Apply Aquatrols Advantage Pellets as often as needed to relieve turf stress. Pellets may be used in conjunction with your regular turf management program.
