GENERAL INFORMATION
SuperSorb C may be used in the installation and production of trees, shrubs, foliage, bedding plants, containers, hanging baskets and flow-erbeds. It increases the ability of the soil to hold water and reduces the frequency of irrigation. SuperSorb C may also be used to aid in the establishment of sod and turf seed. SuperSorb C may be injected into established turf using a variety of specialized equipment designed for that purpose. Follow the instructions of the equipment manufacturer.

DIRECTIONS FOR USE
NURSERY, GREENHOUSE, LANDSCAPE AND INTERIORSCAPE
Amending Mixes: Thoroughly incorporate 1.5 lbs of SuperSorb C per cu yd of media or soil. (1.5 lbs of SuperSorb C is equivalent to 1 qt by volume dry crystals).

Amending Soils: (Planting Beds) Uniformly incorporate (for best results use a mechanical tiller) 2.75 lbs SuperSorb C per 100 sq ft to a depth of 6 inches.

Transplanting Rooted Cuttings, Seedlings, Bedding Plants: Use .25 tsp for each 4 inches of root diameter. Thoroughly mix SuperSorb C into the soil around each plant.

Transplanting Trees and Shrubs: One (1) scoop (enclosed equals 1 oz wt). Use 1 scoop per 1 foot of rootball diameter or 5 gal container. For larger or smaller plants, multiply or divide accordingly. Thoroughly mix ½ of the SuperSorb C with backfill and work the remaining ½ throughout the planting hole.

Seeds and Sodding: Uniformly incorporate 3.5 lbs SuperSorb C (or SuperSorb F) per 1000 sq ft (150 lbs/acre) into the top 2-3 inches of soil before sodding or seeding. Note: sloped areas may require up to 200 lbs/acre.
